About the Project

The Combatting Tuberculosis and Malaria in Kenya Project is a capacity development initiative that seeks to address the prevention, diagnosis and management of TB and malaria in Kenya. Co-created by the funding partner, the Ministries of Health and key stakeholders, this **20-month project** will contribute to improving TB and Malaria indicators in six (6) counties in Western Kenya – Bungoma, Kakamega, Busia, Homabay, Siaya and Migori.

1. Main Purpose of Job

The main purpose of this position is to provide MEL technical support to the GSK TB and Malaria project (60%) as well as provide 40% support to other ICD projects in the design, development and implementation of monitoring activities with support to existing Amref MEL Systems.
